ICOMIA: 1966–Present (1)

A Visual Timeline of the International Council of Marine Industry Associations (ICOMIA)

1966 – Foundation

ICOMIA is established to unify national marine trade associations and represent the global recreational boating industry.

1970s – International Expansion

Membership expands, strengthening global collaboration and regulatory dialogue.

1980s – Standards and Technical Leadership

Increased influence in safety and technical standards, including collaboration with ISO on small craft standards.

1990s – Environmental Focus

Engagement with the IMO and advocacy on emissions, antifouling systems, and environmental responsibility.

Early 2000s – Industry Data Development

Introduction of coordinated global recreational boating industry statistics and enhanced economic impact reporting.

2008–2010 – Financial Crisis Response

ICOMIA: 1966–Present (2)

A Visual Timeline of the International Council of Marine Industry Associations (ICOMIA)

2014 – Global Statistics Benchmark

Launch of a comprehensive global recreational boating industry statistics report, establishing an international reference point.

Celebration of fifty years of leadership with an expanded global footprint including Asia-Pacific and emerging markets.

2020 – COVID-19 Coordination

Facilitated international information-sharing and safe reopening guidance during the pandemic as boating demand increased.

2022–Present – Sustainability and Decarbonisation

Focus on electrification, alternative fuels, lifecycle responsibility, and regulatory harmonisation across more than 35 national associations.

In June 1966, during the 5th IFBSO Congress, the International Boat Trade Association was formed, and consisted of the following representatives:

- Mr AW Mackerer (USA)
- Mr AR Moody (UK)
- Mr JP Jouet (France)
- Mr G de Vries Lentsch (Netherlands)
- Mr G Eriksen (Sweden)

With Tom Webb, the Ship and Boat Builders Federation's Secretary General asked to provide Secretarial services.

The first meeting of this steering committee, known as the 'Steering Committee of Boating Trade Presidents', was held in the Avenida Palace Hotel in Barcelona on 13 November 1966. It was at this meeting the International Council of Marine Industry Associations – ICOMIA – was formed.

From humble beginnings with grand ideas, ICOMIA has always been at the forefront of the industry.

Today membership is estimated to represent more than 80% of the world's leisure boating business.





In 2026, ICOMIA continues to grow with members spread across the globe. This reinforces the thinking that a collaborative way of operating is a way to strengthen all aspects of the industry we love so much.
