




Marine Card

A Safe Marine Business approach to basic Workplace Health & Safety management for the marine sector.

- Improves WHS practices, build better systems of compliance, increase and safety awareness
- Streamlines registration and sign-in process for visitors entering work sites
- It assists businesses understand their obligations and duties regarding the safety of people working on site
- The Marine Card is 'Best Practice' for the marine industry, and understanding of obligations








Marine Card for Contractors

Under modern WHS law, everyone in a workplace has responsibility for safety

 Contractors can carry out the Marine Card Workplace Health & Safety induction online

Modules include –

- Legislation
- Knowledge of obligations under WHS Act 2011
- Hazard identification and risk assessment
- Material Safety Data Sheets
- Safety signage
- Once completed insurance documents can be uploaded to the user profile
- The Card is accepted as evidence of having completed the training and have appropriate insurances in place by participating sites








Marine Card for Marinas

Marinas have an obligation to ensure the safety and well-being of all those who come onto their site

- Marine Card allows marinas to manage all trades and visitors to a marina or marine facility in one place
- It ensures visitors entering the site to work are confirmed as having completed the induction and are covered by relevant insurance
- Full visual tracking and identification of all those visiting a marina site










The Access Management System (AMS)

A software solution for managing site access

- The Access Management System provides managers with a dedicated portal for managing visitors
- It makes signing-in and out quicker and easier, without the need for checking paperwork and chasing insurance
- QR code technology provides a streamlined experience
- Businesses can monitor who is working on-site, what they are doing









The Access Management System (AMS)

Functional components

- CRM database for all workers, including skills, qualifications, insurances
- Search capabilities for vessel owners, searching for a skilled worker / contractor
- Tracking and safety system for Business workplaces, including sms messaging
- International capabilities for tracking and introducing workers globally, based on qualifications, skills, work preferences etc. (several points in development)
